

Trade with breeding animals





Determines amount of financial means for subsidies for keeping traditional and authentic breeds

NATURE PROTECTION ACT

System for protection of nature including overall biological and landscape diversity (traditional and protected breeds

CONVENTION ON BIOLOGICAL DIVERSITY

Croatia accepted Convention on biological diversity (Rio de Janeiro 1992)
